**AN ACT TO AMEND SECTION 1(aa)(3) OF CHAPTER V
(EXECUTIVE BRANCH), PUBLIC LAW 38-60,
RELATIVE TO AUTHORIZING THE GUAM FIRE
DEPARTMENT TO EXPEND FOUR HUNDRED FIFTY
THOUSAND DOLLARS (\$450,000) FROM THE
DEPARTMENT'S UNEXPENDED APPROPRIATED
FUNDS FROM PRIOR FISCAL YEARS FOR A "911
SURCHARGE" RATE STUDY PURSUANT TO 12 GCA
CHAPTER 12.**

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Section 1(aa)(3) of Chapter V (Executive Branch), Public Law 38-

3 60 (General Appropriations Act of 2026), is *amended*, to read:

4 "3) Unexpended Funds from Prior Fiscal Years. Unexpended appropriated

5 funds available to the Guam Fire Department in prior fiscal years shall not lapse and

6 shall be available in Fiscal Year 2026. Notwithstanding any other provision of law,

7 the Guam Fire Department is authorized to expend the sum of Four Hundred Fifty

8 Thousand Dollars (\$450,000) from the department's unexpended appropriated funds

9 from prior fiscal years for a "911 Surcharge" Rate Study pursuant to 12 GCA,

10 Chapter 12, which authorizes GFD to petition the Public Utilities Commission

11 (PUC) for an amendment to the monthly "911 Surcharge" rate from time to time.

12 Funds provided herein shall cover costs associated with GFD's petition to the PUC

1 including a professional services agreement with a qualified consultant or
2 consultants, public notice and hearing requirements, and legal services rendered by
3 the Office of the Attorney General. Funds shall not be subject to *I Maga'hågan*
4 *Guåhan's* transfer authority and shall remain available to GFD until fully expended
5 pursuant to this Act.”

6 **Section 2. Effective Date.** This Act shall become effective upon enactment.
