AN ACT TO ADD A NEW SECTION 1(m)(8) TO CHAPTER V (EXECUTIVE BRANCH) OF PUBLIC LAW 38-60, RELATIVE TO PROVIDING THE GUAM POLICE DEPARTMENT WITH CONTINUING APPROPRIATION AUTHORITY FOR CRITICAL OBLIGATIONS INCLUDING THE REPAIR OR REPLACEMENT OF THE HEATING, VENTILATION, AND AIR CONDITIONING (HVAC) SYSTEM AT THE GREGORIO G. PEREZ CRIME LAB BUILDING IN MANGILAO.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new Section 1(m)(8) is *added* to Chapter V (Executive Branch) of Public Law 38-60 (General Appropriations Act of 2026), to read:

“(8) Unexpended Funds from Prior Fiscal Years. Unexpended appropriated funds available to the Guam Police Department in prior fiscal years shall not lapse and shall be available in Fiscal Year 2026. Notwithstanding any other provision of law, the Guam Police Department is authorized to expend Two Million Dollars (\$2,000,000) from the department’s unexpended appropriated funds from prior fiscal years for the repair or replacement of the HVAC system at the Gregorio G. Perez Crime Lab Building in Mangilao. Funds shall not be subject to *I Maga’hågan*

1 Guåhan's transfer authority and shall remain available to GPD until fully expended
2 pursuant to this Act."

3 **Section 2. Effective Date.** This Act shall become effective upon enactment.
